Our Camp Namesake

J. M. "Matt" Barton

James M. "Matt" Barton was born about 1842 in Pickens District South Carolina. His father was Benjamin Barton and his mother's maiden name was Baker. Barton married Emily Miller and they had five children.

While living in the Rusk County community of Millville he was elected sheriff and served for eight to ten years. During the Mexican War he served as a second lieutenant in Capt. Ferguson Aston's Company G of Col. George T. Wood's Second Regiment, Texas Mounted Volunteers. This company was organized in the area of Sand Hill, Texas. During the War Between the States he was elected LT. Col. Of the 10th Texas Cavalry.

In the first few months of the war this unit served in Arkansas, Louisiana and Texas. Later they were transferred to Ector's Brigade of the Army of Tennessee which was consolidated with the 14th Texas Cavalry. Barton resigned his commission before the close of the war because of ill health. He was a successful merchant, first in Belleview TX, then Hallsville, TX and finally at Longview, Texas. After the Longview store burned he retired to his Belleview farm. He was serving as sergeant-at-arms of the Texas Senate at the time of his death in September 1879, just one year after the death of his wife.

Sat Oct 6 – Grave Dedication for confederate soldier, Souls Chapel Cemetery, Upshur Co. TX. Muster - 10:00 am – Service - 11:00 am. Lunch will be provided.

Directions from Gilmer – Take Hwy 154 west to FM road 852 west. Go appox 5 miles. Turn on FM RD 556 north and go appox 5 miles and the Cemetery will be on the right side of road.

Sat Oct 20 – Gilmer Yamboree Queens Parade, Gilmer, TX. Muster 9:30 - 10 am on Titus St. west of the Gilmer National Bank. Parade – 11:00 am. Trailer available for the ones that are unable to march. Look for trailer with flags.

Sat Oct 27 – Grave Dedication for Confederate Soldier, Pvt. Edward Terry gg-grandfather of Color Sgt. George Linton at Terry Homestead Cemetery. **Muster – 10:00 am – Service – 11:00 am.** Lunch will be provided.

Direction from Gilmer – Take Hwy 155 north to intersect Hwy 59 north at Linden. Turn left on Hwy 59 north to Atlanta TX. Turn right on Hwy 77 south to TX and LA state line. At the state line turn left on Brown Cemetery RD northeast until you intersect Miller Co. Rd. 1. Turn right-south and go about 4 or 5 miles (part of this will be a dirt road). Cemetery will be on the left side of road about 100 yards. I will try to have some marker signs up.
