## **Call To Action:**

Compatriots I have found out from the Texas Division that 2 monuments protection Bills have been filed this session of the Texas Legislature. We need to contact our State Senator and our State Representative and ask them for their support of these Bills. At this time they have been filed in the Senate and in the House. We must ask to get them out to committees to at least be discussed. Last Session these Bill died setting in the Calendar Committees. If they do not get out of the Calendar Committee they do not get to the assign committees to get to the Floor for a vote. It is time for our elected Officials to protect our heritage.

House Bill 583 by Representative James White from Woodville along with Senate Bill 226 by Senator Pat Fallon from Prosper both offer protection of monuments erected to honor Veterans on City, County or State property. I will include copies of these Bills for you to study and understand these Bills. I ask that you then call, write or email your Senator or Representative.

### **How Do I Join The Sons of Confederate Veterans?**

The SCV is the direct heir of the United Confederate Veterans. Organized at Richmond, Virginia in 1896, the SCV continues to serve as a historical, patriotic, and non-political organization dedicated to ensuring that a true history of the 1861-1865 period is preserved. Membership in the Sons of Confederate Veterans is open to all male descendants of any veteran who served honorably in the Confederate armed forces. Membership can be obtained through either lineal or collateral family lines and kinship to a veteran must be documented genealogically. The minimum age for full membership is 12, but there is no minimum for Cadet membership.
